


Foreign Trade in Goods

December 2020

Tirana, January 18, 2021: On December 2020 the value of exports was ALL 23 billion, increasing by 5.4 % compared with the same period of previous year and decreased by 15.6 % compared with November 2020. The value of imports was ALL 61 billion, increasing by 10.5 % compared with the same period of previous year and by 10.1 % compared with November 2020. This month the trade deficit is ALL 38 billion, increasing by 13.9 % compared with December 2019 and by 34.8 compared with November 2020.

In 2020, the value of exports was ALL 272 billion, decreasing by 9.0 %, compared with previous year and the value of imports was ALL 605 billion, decreasing by 6.8 % compared with previous year. Trade deficit was ALL 333 billion, decreasing by 9.9 % compared with 2019.

The influence of the main groups in the annual change in exports:

In annual increase of exports by 5.4 % this month, a positive contribution was given by the groups: "Construction materials and metals" with +6.3 percentage point, "Machinery, equipment spare parts" with +2.8 percentage point, "Food, beverages, tobacco" with +1.7 percentage point. "While a negative contribution was given by the groups: "Minerals, fuels, electricity" with -6.3 percentage point, "Leather and leather manufactories" with -0.2 percentage point.




Fig.2 Contribution of groups in annual change of exports, December 2020

Exports during 2020 are decreased by -9.0 % compared with the same period of previous year. The main groups that influenced more in annual decrease of exports are: "Textile and footware" with -5.3 percentage point, "Minerals, fuels, electricity" with -3.5 percentage point, "Construction materials and metals" with -1.2 percentage point. While a positive contribution was given by the group: "Food, beverages, tobacco" with +1.2 percentage point and "Machinery, equipment spare parts" with +0.5.

The influence of the main groups in the annual change in imports:

In annual increase of imports by 10.5 %, this month has mainly affected the groups: "Construction materials and metals" with +3.1 percentage point, "Chemical and plastical products" with +3.0 percentage point, "Machinery, equipment spare parts" with +2.7 percentage point. While, a negative contribution was given by the groups: "Food, beverages, tobacco" with -0.8 percentage point, "Leather and leather manufactories" with -0.5 percentage point.

In 2020, imports are decreased by 6.8 % compared with previous year. The groups affected negativity in annual decrease of imports, are: "Minerals, fuels, electricity" with -3.5 percentage point, "Textile and footwear" with -1.8 percentage point, "Machinery, equipment spare parts" with -0.8 percentage point. While a positive contribution was given by the group: "Chemical and plastical products" with +0.4 percentage point, "Food, beverages, tobacco" with +0.1 percentage point.

The performance of trade in goods by partner countries

In December 2020, countries with which Albania has had the highest increase of exports, compared to December 2019 are: Italy (4.8 %),Kosovo (21.1 %) and Greece (6.8 %). While, countries with which has had a decrease of exports are: Spain (61.4 %), Germany (10.2 %) and Montenegro (15.1 %).


In 2020, countries with which Albania has had the highest increase of exports, compared to 2019 are: Germany (12.8 %), Greece (3.4 %) and North Macedonia (3.4 %). While, countries with which has had a decrease of exports are: Italy (13.7 %), Kosovo (12,0 %) and Spain (30.4 %).

In December 2020, countries with which Albania has had the highest increase of imports, compared to December 2019 are: Italy (19.1 %), Greece (42.1 %) and China (1.0 %). While countries with which has had a decrease of imports are: Turkey (9.4 %), Germany (0.4 %) and USA (7.1 %).

In 2020, countries with which Albania has had the highest increase of imports, compared to 2019 are: Greece (0.2 %), Germany (0.3 %) dhe Serbia (77.8 %). While, countries with which has had a decrease of imports are: Italy (7.4 %), Turkey (6.2 %) and China (9.5 %).

Foreign Trade in Goods





Trade with the EU countries is 61.3 % of total trade. In December 2020, exports to EU countries occuped 68.9 % of total export and imports from EU countries occuped 58.5 % of total import. The main trade partners remain: Italy (30.1 %), Turkey (8.2 %), Greece (7.9 %) and China (7.0 %).

Trade with the EU countries, in 2020 is 63.1 % of total trade. During this year, the share of exports to EU countries was 74.7 % of total export and share of imports from EU countries was 58.0 % of total import. The main trade partners are: Italy (31.4 %), Greece (7.7 %), Germany (7.1 %) and Turkey (7.0 %).

Methodology

Exports are goods destined to a third country, placed under customs export or outward processing arrangements or re-exported following inward processing.

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs frontier.

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under customs procedure of release for free circulation, inward processing or processing under customs control.

The cost, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing country, or the price of a service delivered to resident, before the payment of any import duties or other taxes on imports or trade and transport margins within the country.

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics and for customs tariffs.

Member State of European Union: Belgium, Germany, France, Italy, Luxembourg, Netherlands, Denmark, Ireland, Greece, Spain, Portugal, Austria, Finland, Sweden, Cyprus, Czech Republic, Estonia, Hungary, Latvia, Lithuania, Malta, Poland, Slovakia, Slovenia, Bulgaria, Romania, Croatia.
